Canal Village Farmers' Market (CVFM) will be hosting a "Holiday Market" this year. It will be set up INDOORS at 345 Main Street (former NAPA Parts store). There is a fee of \$50 for the Holiday Season (11/4-12/23) or \$25 for individual Saturdays. For 11/25 *only* (Olde Tyme Christmas), the fee is \$35 for a 10'x10' space. There is limited space available and it will be on a first come first serve basis.

Vendor Responsibilities:

1. Bring your own tables, chairs and dress appropriately for the weather. (The building is heated)
2. Set up stand to *be ready for the public by 9AM. Sales close at 1:00PM. **Vendors will not commence dismantling of display until 1:00PM.***
3. The market runs until 1:00PM. *Except November 25 for Medina's Parade of Lights & Olde Tyme Christmas Celebration **when close time is 4:00PM.***
4. Food vendors please contact CVFM via the phone number or email below.
5. There will be a small additional fee for any electricity used.

• **Note: Canal Village Farmers' Market reserves the right to deny a vendor at any given time before or during the event based on unprofessional conduct, duplicate products, tardiness to the event, lack of food permits or non-compliance.**

I verify that the information I have provided in this Holiday Market Application is complete, true, and accurate to the best of my knowledge.

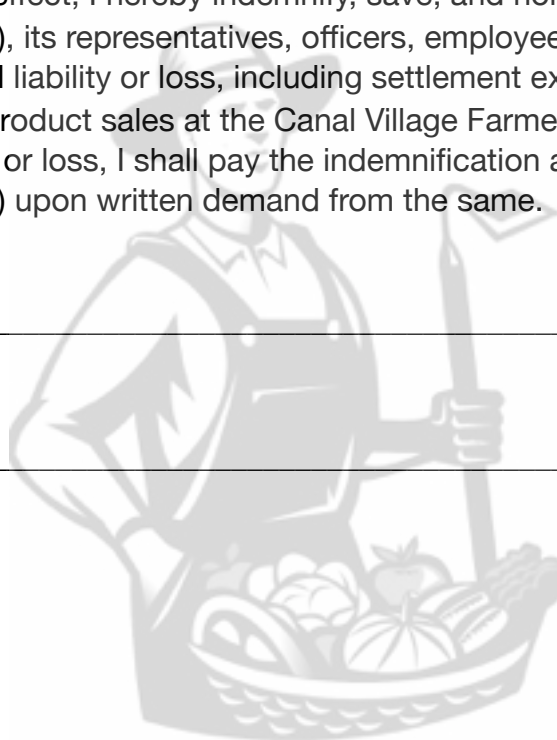
